

Rental Agreement



The terms and conditions are set out below and by accepting the rental agreement you are consenting to these. All instruments remain the property of Carr's Strum-Stop regardless of how long you hire the instrument for.

- Responsibility** All instruments hired must be taken care of under the guidelines given for each instrument.
 It becomes the responsibility of the signatory of the rental agreement to ensure that the instrument is stored correctly and to avoid potential risk areas where it may be damaged or stolen.
- In the event of loss of instruments (or any part of the equipment provided) the hirer will be responsible for the full replacement cost and will reimburse the owner (Carr's Strum-Stop) for the full current cost of replacing the equipment.
 - The hirer is responsible for all repair and maintenance costs to keep the instrument in perfect playing order. (This includes cases, capos, straps, bows, cables,).
 - The hirer undertakes to keep the instrument insured to the full value against fire, theft, and other perils under an "All Risks" policy and accepts responsibility to pay the full price in the event of a mishap or accident.
 - The hirer will make punctual payment of scheduled fees and will contact Carr's Strum-Stop should there be any reason why payment will not be made.
 - Should the hirer wish to terminate the contract, one month's written notice must be given. Where notice is not received an additional month's rental will be levied.
- Payments** The full deposit and first month's rental must be paid before any instrument will be released.
 Payments will be made by EFT.
 Deposits will be returned in full once instruments have been returned and tested. Should there be any damage to the instrument or any parts/accessories missing, your deposit may be used to cover the costs incurred when fixing the instrument or replacing the parts/accessories.
 Instruments are rented and billed monthly, weekly or daily.
- Instrument** All Instruments will be issued in good working condition.
 Accessories required for certain instruments will be for the account of the hirer. (reeds, etc)
 Accessories that are part of the instrument hire, must be returned when the instrument is returned.
- Owners right** If any of these terms and conditions are breached, Carr's Strum-Stop may, without notice, recover any of the amounts outstanding, resume possession of the musical instrument, and/or terminate this agreement.
